## Selection Procedure of Alumni for Distinguish Alumnus Award:

Following procedure is proposed for the implementation of this initiative:

#### Title of the award:

Award will be named as "Distinguished Alumnus Award" for the year (say) 2018. Further a trophy/memento and a citation will be presented. Initially two Alumni may be considered every year which can be increased in future.

#### 2. Inviting Nominations:

The Alumnus is to be nominated by the Alumni. There will be **one Alumnus** nominated from each batch (batch means year of passing). Every year nomination will be proposed and seconded by his/her batch mates only. Same nominee can be repeated next year if not selected for DAA. Nomination may be submitted by filling the form or collected through website and other published material by MMMUT. There should be no self-nomination. Current members of Executive Body of MMMUT Alumni Association will not be eligible for this award. For DAA award the decision of nomination committee after the approval of President, MAA will be final.

#### Eligibility Criteria:

All those Alumni of MMMUT (Erstwhile MMMEC) who have completed their BE/B Tech, MCA or MBA programme and having 18 years of work experience will be considered. This means that up to 2000 batch, the nomination will be considered this year.

#### 4. Evaluation Criteria:

 Leadership in the organisation/Institution, positions held at various job levels with durations (number of years) and important contributions.

b) Positions of leadership in Professional bodies, Industry Associations, positions held with duration and important contributions.

#### Annexure-III

## Rules for the allotment of Alumni Bhawan, MMMUT Gorakhpur
